

## Coronavirus/COVID-19 -- Assumption of Risk and Waiver of Liability

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments, and federal and state health agencies, recommend social distancing and have, in many locations, prohibited the congregation of groups of people. By signing this Waiver of Liability, you represent to Green Mountain Junior Football Association (GMJFA) and its parent, subsidiary, affiliated entities, and all entities conducting Green Mountain Junior Football Association events, practices, leagues, tournaments or instruction (together and collectively, "Green Mountain Junior Football Association") and that you and your child(ren) have not, in the past 14 days: knowingly been in contact with any one that has tested positive for COVID-19; exhibited any symptoms commonly associated with COVID-19, including fever; or traveled outside the United States. In an attempt to address the risks that COVID-19 presents, including to reduce the spread of COVID-19, Green Mountain Junior Football Association has previously sent out emails which outlined State and Federal recommendations. However, if you or your child(ren) attend a Green Mountain Junior Football Association event, practice, league, tournament or instruction Green Mountain Junior Football Association does not and cannot guarantee that you or your child(ren) will not be exposed to or become infected with COVID-19, or spread COVID-19 to others.

### **By signing this Assumption of Risk and Waiver of Liability, you expressly and knowingly:**

1. Acknowledge the contagious nature of COVID-19; and
2. Voluntarily assume the risk that you or your child(ren) may be exposed to or infected by COVID-19 at a Green Mountain Junior Football Association event, practice, league, tournament or instruction and all spectators attend at their own risk.

You voluntarily agree to assume the risk that you or your child(ren) may be exposed to or infected, you or your child(ren) could spread COVID-19 to others. You accept sole responsibility for any mental distress, personal injury, illness, temporary or permanent disability, and/or death that you, your child(ren) or others with which you have personal contact may experience or incur if you become COVID-19 infected as a result of you or your child(ren)'s attendance at a Green Mountain Junior Football Association event, practice, league, tournament or instruction.

You waive and release Green Mountain Junior Football Association and all associated officers, directors, members, directors, managers, agents, employees, consultants, representatives, volunteers, and/or all other Green Mountain Junior Football Association (event, practice, league, tournament or instruction) participants and/or their families, family friends and spectators ("USA PRIME FOOTBALL Parties") from all actions, damages, losses, costs, claims, liability, or expense, of any kind of nature, that you or your child(ren) suffer or incur from exposure to or infection by COVID-19 as a result of attending, arising out of, or related to, a Green Mountain Junior Football Association event, practice, league, tournament or instruction (a "Claim").

On your behalf, and on behalf of your child(ren), you hereby release, covenant not to sue, discharge, and hold harmless Green Mountain Junior Football Association and the Green Mountain Junior Football Association Parties from and against the Claims. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Green Mountain Junior Football Association or a Green Mountain Junior Football Association Party, including any Claim based on lack of, or error in carrying out, COVID-19 preventative measures and protocols, and regardless of whether a COVID-19 exposure or infection occurs before, during, or after participation in any Green Mountain Junior Football Association
